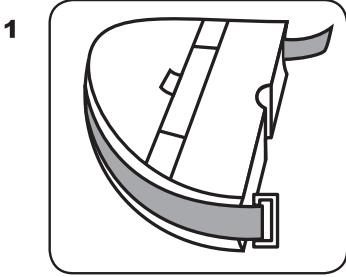




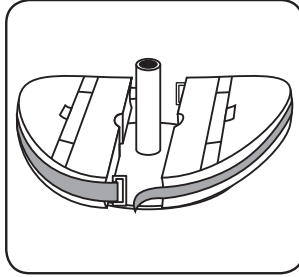

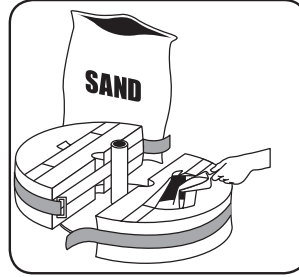
DUO ROUND™ SET-UP GUIDE



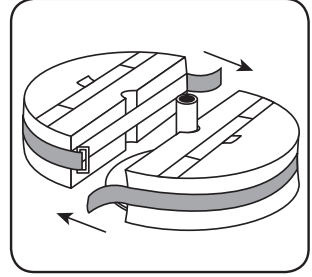
1 Unfold both halves of the DUO™ Gravipod™ Umbrella Weight Bags.



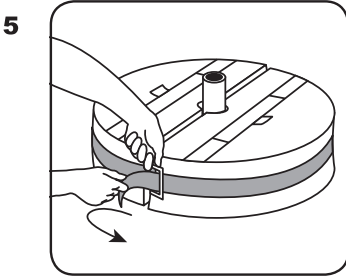
2 Position both halves on the umbrella stand with the Easy-Fill ports facing up.



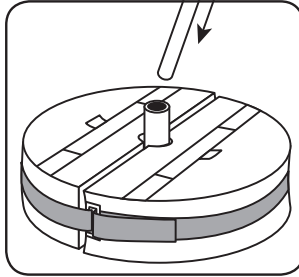
3 Using a scoop or funnel, fill each of the DUO™ weight bags with approximately 50lbs/22.5kg of clean dry sand.



4 Pull halves together, as close to the center as possible, around the umbrella stand.



5 Take velcro Secure-Attach straps and run through the buckles on adjacent weight bag.



6 Set the umbrella back into the stand – your DUO™ Gravipod™ weight bag is ready to go to work! Total weight equals 100lbs/45kg.

Our Lifetime Guarantee covers all of our Canopy and Umbrella Weight Bags lines. Premier Tents will repair or replace, at its discretion, any manufacturing defect in these products free of charge. This warranty guarantee does not cover damage caused by normal wear and tear, accidents, improper care, or non standard usage or negligence. Products purchased must be purchased from an Authorized Premier Tents dealer and should be returned to us for evaluation.

***Lifetime**

The term Lifetime refers to the lifetime of the product. Unfortunately, it doesn't mean your lifetime or ours, but rather the lifetimes of the components, fabrics, and materials. While we choose the very best materials available to make our products as durable as possible, all materials degrade over time with use and exposure to the elements and a product's lifetime is a function of how much use it gets and how well it is cared for and not by how old it is.

***Manufacturing Defects**

A manufacturing defect exists if the product departs from its intended design. Defective materials (zippers, buckles, fabrics, etc.) or workmanship (seams, construction, etc.) are covered by our Premier Tents warranty for the lifetime of the product. Premier Tents will repair or replace at its discretion any manufacturing defect in these products free of charge.

***Wear and Tear**

Wear and Tear is damage that naturally and inevitably occurs as a result of normal use. Moving parts will wear out and fabrics will deteriorate and fade over time. And while we choose the best materials available for the application, all materials degrade over time with use and exposure to the elements.

Submit a Warranty Claim:

All returned products are required to be clean and dry for warranty evaluation. If the claim is determined to be valid, the product will be replaced at Premier Tents expense within 10-15 days.
